



"The Quorum for all meetings of members shall be twice the number of directors present plus one additional member entitled to vote at the meeting.







Publicity Achievements

- Increased number of articles/notices for NRT (which are also on FB and website)








- •The following presentation is a summarized version of that information but presented in a Q&A format.




What was the year like?

- •It was 2018 'turned inside out'
 - •The investment portfolio went from -5.1% to +11.3%
 - •We disbursed ½ as much as in 2018






How was the investment recovery used?




- 1. We replaced all of the capital that had to be drawn down in 2018 (4% across all the funds)
- 2. We put \$10,000 back into the Reserve Fund (that had been drawn down to \$0 in 2018)
- 3. We added 1% into the capital of each fund to offset inflation
- 4. The remaining \$43.5k was added to the disbursable earnings




Where Did We Spend Cash in 2019?


What were the significant financial events in 2019?



Accepted to participate in RBC Future Challenge Project

- A local youth team won a \$15,000 flow-through award for "PEP Talks"
- Structural support for local charities
 - Managed flow-through donations from fund-raising dinner to Bernadette McCann House
- Sources of Donations
 - Donations received through both PayPal and Canada Helps
 - Notified that the foundation was named as the sole beneficiary of John Moore estate

How Did Our Investments Perform in 2019?



•2019 - 10.8%

- The fixed income portfolio (51% of investments) returned -0.2%
- The equity portfolio (49% of investments) returned 19.0%.

•Since 2006


- •14 year average 5.27%

How is 2020 Shaping Up? Investments


Still Crazy after all these years –apologies to Paul Simon





Year to Date is -12% Equity, +6% Fixed, -6% Overall

Surely there must be some Good News? Absolutely!



- John Moore left his entire estate to the Foundation -\$250k to date with some still to come
- 2nd International Women's Day Fundraising Dinner was a great success - \$10,700 net (divided 50:50 between Bernadette McCann House and Women's Day endowment fund)
- DRDCF accepted to participate in Emergency Community Support Fund (ECSF) through Community Foundations Canada - \$40,000 distributed to help local charitable organizations deal with Covid-19 costs

ECSF Grants




\$20k to **Deep River and District Hospital** (including Four Seasons Lodge, and North Renfrew Family Health Team) - to support COVID-19 response measures to protect the health and safety of patients, residents, staff and the community

\$8.2k to **Easter Seals Ontario** - to support children and youth in our area with physical disabilities who require dedicated in-home equipment during COVID-19

\$8k to **Deep River and Area Food Bank** - to support COVID-19 response measures in providing sustainable service to our clients


\$3.8k to **North Renfrew Long Term Care** - to provide additional PPE (i.e. surgical/procedure masks) to protect the health and safety of patients, residents, staff and the community







Appointment of Public Accountants



 Moved that the firm of Scott, Rosien, Black & Locke of Pembroke Ont. be retained as the public accountants for the 2020 fiscal year


