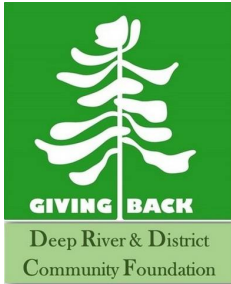

## THIRD PARTY FUNDRAISING GUIDELINES AND AGREEMENT

Deep River and District Community Foundation (*DRDCF*) welcomes local community groups, individuals and others who wish to host fundraising events ("**Third Party Fundraising**") where all or a portion of the proceeds goes to the Foundation generally or one of our funds with a specific focus. This is a very effective way to help fund the many worthwhile charities and other community projects supported by DRDCF.

It is important to have a clear understanding between the organizer of **Third Party Fundraising** and **DRDCF** of our guidelines, and requirements of **Canada Revenue Agency**. Upon successful application by a **Third Party Organization**, DRDCF will consider this application and if successful grant an **Endorsement Letter** with the understanding that you adhere to the following **Fundraising Guidelines**:

- All fundraising activity must be endorsed by DRDCF. Donations will only be accepted from individuals, organizations, and companies whose image supports the values, mission and strategic objectives of DRDCF.
- Once we have received your signed **Third Party Fundraising Guideline/Agreement and Third Party Fundraising Event Description Form** and we are satisfied that the fundraising activity fits with the values, mission and strategic objectives of the Foundation, we will forward you an **Endorsement Letter**.
- If an event or activity, which is to benefit the Foundation, is approved, it must be stated that proceeds will be directed to Deep River and District Community Foundation.
- All fundraising activities must be undertaken to promote the community standing, good name and services of DRDCF.
- Monies raised via fundraising activities must be for the stated purpose of the appeal.
- An event or activity organized by a **Third Party Organization** is not an official DRDCF event or activity.
- No statement in third party advertising should imply that a product or service is recommended or endorsed by the Foundation.
- All events and/or activities must be held for the stated purpose and within the timeline outlined in the completed third party application.
- **Third Party** organizers must take sole responsibility and liability for the planning, promotion and management of an event or activity. This may include soliciting prizes, organizing publicity and providing goods and services. DRDCF may provide guidance and support when needed.
- The Third Party must ensure that its officers, employees, agents, partners, volunteers, contractors and associates do not represent or hold themselves out as having any authority to act on behalf of DRDCF.

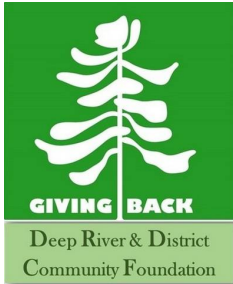

- DRDCF reserves the right to approve any media release, artwork, description of an event or activity and wording before it is published or distributed.
- DRDCF's Public Liability Insurance does not cover **Third Party Fundraisers**.
- DRDCF recommends that **Third Party** events or activities encourage members of the public who wish to make a donation, to do so directly to Deep River and District Community Foundation on the web at <http://DRDCF.ca> or by contacting [info@DRDCF.ca](mailto:info@DRDCF.ca)
- Where the Third Party Organization is collecting the Donation Funds, then they must agree to also provide the required donor information so that tax receipts can be issued, as per the DRDCF Donation/Receipt Log and submit the form along with all funds received.
- Receipts for tax purposes can only be issued to people giving donations of money (above \$10.00). The following are not tax deductible: raffle ticket purchases, purchases of goods (e.g. chocolates, merchandise) or services, purchases of goods and services at an auction.
- Total income and expenditure reports for the event or activity should be submitted along with a cheque or money order within 28 days of the end of the event or activity.
- DRDCF reserves the right to withdraw its approval for the fundraiser/event at any time if it appears that there is a likelihood of the fundraiser failing to adhere to any of the above Guidelines. Further to this, Endorsement Letters will not be issued where the viability of the fundraising activity is in doubt.
- Information required to be collected from donors to meet **Canada Revenue Agency (CRA)** for Donation receipt requirements

  - the date the donation/gift was received
  - the full name, including middle initial, and address of the donor
  - the donation amount
  - the amount of any [advantage](#) received by the donor
  - the amount of the [eligible amount of the donation/gift](#) (Excluding advantage)
